**MUNICIPALITY OF WHITESTONE
NOTICE OF A PUBLIC MEETING
CONCERNING AN OFFICIAL PLAN AMENDMENT PURSUANT
TO THE PLANNING ACT, R.S.O. 1990 (Section 17, 22, 26)**

TAKE NOTICE that a Public Meeting will be held **Tuesday, November 19, 2013 at 6:30 pm at the Dunchurch Community Centre** to provide the public an opportunity to review and comment on the proposed amendments that are proposed to be considered as part of the Official Plan Review and Zoning By-law Review. The Official Plan Review and subsequent amendments apply to all land in the Municipality of Whitestone.

THE PURPOSE AND EFFECT of the proposed Official Plan Amendment is to update the Official Plan as required under Section 26 of the Planning Act to make the necessary changes to reflect updated Provincial policy and legislation and to provide direction on new and emerging planning issues in the Municipality.

No Key Map is attached since the Official Plan Amendment applies to the whole of the Municipality. A copy of the complete proposed Official Plan Amendment is included on the Municipality's website at: www.whitestone.ca or can be viewed at the municipal office during normal business hours.

ANY PERSON may make written and/or verbal representations whether in support of or in opposition to the proposed Official Plan Amendment.

AND TAKE NOTICE that if you wish to be notified of the adoption of the proposed Official Plan Amendment you must make a written request to the Council of the Municipality of Whitestone, 21 Church Street, Dunchurch, Ontario P0A 1G0.

AND TAKE NOTICE that if a person or public body does not make oral submissions at a public meeting or make written submissions to the Council of the Municipality of Whitestone before the proposed Official Plan Amendment is adopted, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Whitestone to the Ontario Municipal Board.

AND TAKE NOTICE that if a person or public body does not make oral submissions at a public meeting or make written submissions to the Council of the Municipality of Whitestone before the proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.

ADDITIONAL INFORMATION including the Official Plan Amendment is available for inspection at the municipal office during normal office hours.
